



## MENEGHETTI AWARD 2014

### FOR RESEARCH ON ECONOMICS, MEDICINE, PHYSICS AND PHILOSOPHY

The Antonio Meneghetti Scientific and Humanistic Research Foundation hereby launches an award, also in accordance with the Foundation's bylaws, for research on **Economics, Medicine, Physics** and **Philosophy** as applied to the field of Ontopsychology.

The Foundation aims to disseminate and promote Ontopsychological thought, as expressed in Professor Meneghetti's fundamental books, and the adoption of integral humanism in philosophical, scientific, artistic and business practices. The Foundation has no specific support limitations and does not engage in for-profit pursuits.

The award is designed to give recognition to the scientific quality of an original study in the fields of economics, medicine, physics and philosophy that might be related in any way to ontopsychology.

#### Award

To this end, the Antonio Meneghetti Foundation will award the sum of EUR 15,000.00 (fifteen thousand) in each of the four areas of Economics, Medicine, Physics and Philosophy.

Awards can be given also to two or more ex-aequo winners in each category. In this case the sum of EUR 15,000.00 (fifteen thousand) will be split equally among the winners.

#### Participation requirements

Each scientific submission can be:

- a research paper published in an international journal not earlier than 2012;
- or an original study: consideration will be given only to complete and print-ready manuscripts, inclusive of all notices confirming that all the formalities related to rights and copyrights have been fulfilled by the Author.

Candidates must have a University Degree (Master's degree level) or must have published at least an extensive article on Ontopsychology in a scientific journal.

In case of publications with multiple Authors, participation in the award is open to the submitting Author who has received the written consent of his or her co-Authors.

#### Award terms and conditions

Candidates are required to fill and submit an application (Annex A) to the Foundation both by e-mail to [awards@fondazionemeneghetti.ch](mailto:awards@fondazionemeneghetti.ch) and in paper format to Fondazione di Ricerca Scientifica ed Umanistica Antonio Meneghetti, Via G. Cattori 11 – 6900 Paradiso – Switzerland (CH), by 31st March 2014. Compliance with this deadline shall be confirmed by the date of **receipt**. Candidates must attach the publication or the original study (in PDF format for e-mail submissions and in paper format for postal submissions) to the application.



It is the candidates' responsibility to ensure that their submissions have been received.

The result shall be notified directly to the selected Authors via a letter from the Foundation's Chairman within 60 days of the foregoing deadline.

The award's Scientific Committee shall select and recommend to the Foundation's Council the winning submissions. The award's Scientific Committee shall be made up of the Foundation's Chairman and two other members – of an international stature – for each of the four areas, selected from among Ontopsychology scholars. Meetings of the Scientific Committee may be held also online but participation by all its members is required. Resolutions shall be adopted by a majority vote.

All submissions must be written either in Italian or in English. No other languages will be accepted.

### **Evaluation criteria**

The Scientific Committee will review:

- the scientific quality of the publications based on international standards
- pertinence of the subject to Ontopsychological thought.

### **Winner**

In the case of a paper by a single Author, such Author shall be the winner. In the case of multi-authored papers, the award shall be given to the submitting Author who, in turn, is required to attach to the application the consent of the other co-Authors.

### **Documents to be submitted**

Candidates (submitting Authors) need to submit the following documentation:

- an application duly filled (see Annex A) and signed by the candidatè (submitting Author)
- a copy of the candidate's (or submitting author's) valid identity card
- a curriculum vitae not longer than one page
- University degree certificate (Master's degree level)

### **Award ceremony**

The winner will receive the sum during the award ceremony, which will be held in a place and on a date to be designated.

### **Unassigned awards**

The amounts of unassigned awards shall be withheld by the Foundation.

### **Dissemination of results**

The Foundation, in keeping with the intellectual property rights related to the papers that received the award, may undertake initiatives, also in cooperation with third parties, to disseminate and communicate the contents of such papers.
